# ICCI Receives Generous Response to Funding Request

When Interlakes Community Caregivers' spring fundraising events had to be cancelled due to the Coronavirus pandemic, the nonprofit made an urgent request to the community, and the response exceeded expectations, raising over \$16,000.

While adapting to the many challenges the pandemic has forced upon all of us, the need for ICCI to raise funds to provide essential services was important. We are very grateful for the generous support from the community which is a testament to the value of our services.

The two spring fundraisers previously scheduled were the "Spring Fling" at The Mug Restaurant in Center Harbor and Free Cone Day at Ben & Jerry's-Meredith. The loss of these two fundraising events meant Community Caregivers would be short on income on which we were relying and asked the public to make a special donation to offset this shortfall.

Local businesses and individuals had already donated several gift baskets for the Spring Fling event, valued up to \$265. "I am honored to be named the Executive Director of Interlakes Community Caregivers," Rachel said. "This is an incredibly exciting opportunity to utilize my experience and leadership abilities to fulfill the mission of ICCI and make a difference in my community."

Rachel's background includes leadership positions at a variety of nonprofits. She most recently was Director of Institutional Stewardship and International Student Programs at Tilton School. After graduating from William Smith College, she worked for Rachael Saliba

U.S. Congresswoman Claudine Schneider before becoming volunteer for the US Peace Corps in the Dominican Republic. Since then she has worked for various organizations including the Harvard School of Public Health, the Appalachian Mountain Club, Holderness School, Sage Hill School, Berwick Academy, and York Hospital. She has also served on the board or as a member of the United Way Community Impact Committee, Rotary International, Hall Memorial Library, and the Winnipesaukee Public Health Council. She lives in Moultonborough with her husband and three children.

The Search Committee received several applications from candidates for the position. Over the past four months, the committee conducted a rigorous and thorough process of reviewing applications and holding interviews with well-qualified candidates. ### ICCI Continues to Fulfill its Mission During Historic Pandemic

Interlakes Community Caregivers continues to provide essential services during the current Coronavirus pandemic, thanks to our compassionate and flexible volunteers.

In order to meet the needs of our neighbors, we are continuing to monitor our program and services and making adjustments accordingly during the current health crisis. Staff and board members have kept abreast of local, state and federal authorities' guidelines which have required the ability to strategize and modify protocols and procedures to address health and hygiene concerns.

We have been focusing on grocery shopping and running errands for our neighbors. Due to physical distancing, volunteers are not taking neighbors for these essential services, but have been willing to shop for or pick-up and deliver groceries and prescriptions to our neighbors. All include implementation of guidelines provided by public health authorities.

Although most medical appointments have been cancelled by medical providers, some are deemed urgent and neighbors need rides to them. New procedures such as sanitizing the volunteer's vehicle before and after the ride and having the neighbor ride in the back seat have been implemented. Rides to medical appointments typically are the #1 requested service by neighbors, making up about 90 percent of services. Friendly visits have been temporarily suspended, but friendly check in calls have been encouraged to address isolation.

We continue to communicate with medical facilities regarding pending appointments and with local grocery stores to understand and communicate best shopping procedures. Prior to the ultimate temporary lock down of local nursing homes and 55+ communities, we reached out to learn their transitioning requirements.



Thank you to the Meredith Altrusa Club for providing free, hand-made face masks and Liz Breton, Manager of Ben & Jerry's-Meredith, for creating ear savers – a band that loops around the neck and attaches to the mask, making it more comfortable to wear.
